Whereas, the Notification for inviting applications through online mode on prescribed format from the post-graduate candidates who are the domicile of Union Territory of Jammu & Kashmir, having secured minimum 50% marks in post-graduation in their respective disciplines, for their hiring on temporary basis as "**Cluster Resource Coordinators for Teaching Support**" for the academic session 2024-25 (up to 31st March, 2025) in various Government High & Higher Secondary Schools for Kashmir Division, was issued vide Directorate of School Education, Kashmir Notification No: 06-DSEK of 2024 dated: 19-06-2024 issued under endorsement No: DSEK/ GS/ 573/ E-7451889/ 775-89 dated: 19-06-2024, and;

Whereas, District wise, Subject wise tentative Merit Lists for hiring of CRCs for the Academic Session 2024-25 (Kashmir Division) were published on Official Website of Directorate of School Education, Kashmir i.e. www.dsek.nic.in as well as on the dedicated website viz; www.itdsek.com, for the information of concerned individuals and for inviting objections (if any) by or before 08th July, 2024, and;

Whereas, vide the aforementioned notification, it was also provided that the Tentative Merit Lists published were prepared as per the actual data provided in the Application Forms and the final hiring of the candidates shall be subject to the verification of the information contained in their submitted applications/documents by the Committee to be constituted for the purpose, and;

Whereas, pursuant to the directives issued by the Directorate of School Education, Kashmir vide Order No: 171-DSEK of 2024, Dated: 05/07/2024, issued under endorsement No. DSEK/Estt-I/Gaz/824-86 Dated: 05-07-2024, this office, vide Order No.: CEO/Bpr/Gazz-Estt/24/1598-1603, Dated: 08-07-2024, constituted a Committee for scrutinization/ verification of the documents submitted by the applicants for their hiring as Cluster Resource Coordinators for Teaching Support for the Academic Session 2024-25 (up-to ending March-2025), and;

Whereas, after scrutiny of the documents (uploaded by the candidates on the designated portal) by the Committee constitute for the purpose, a re-drawn Short-list/ Wait-lists of candidates were issued vide this Office Notification No: CEO/Bpr/Gazz-Estt/2024/1768-71, Dated: 13-07-2024, for information of all concerned and for inviting objections, (if any) by or before 15th July, 2024, and;

Whereas, the Committee constituted for the purpose, carefully examined/ assessed all the objections received by this Office within the stipulated time with regard to the re-drawn merit list in various disciplines and prepared the Final Merit list for hiring of CRCs along with the waiting list, and;

Whereas, strictly on the basis of merit, the services of **70** candidates for hiring as Cluster Resource Coordinators in various disciplines for the Academic Year 2024-25 was ordered by this Office vide Order No. 143 CEO BPR of 2024, dated 18-07-2024, issued under endorsement No. CEO/ Bpr/ Gazz-Estt/ 024/ 1825-31, dated: 18-07-2024; and the candidates were directed to join at their designated institutions within the period of 05 days from the date of issuance of the said order failing which the candidature of the applicant was deemed to have been cancelled ab-initio, and;

Whereas, as per the report conveyed by the respective HoIs, the following **12** Cluster Resource Coordinators (CRCs) have not joined at their designated Institutions within the stipulated time (i.e, upto 22nd July 2024), and as such their candidature as CRC stands cancelled in light of the guidelines issued vide this office Order No. 143 CEO BPR of 2024, dated 18-07-2024, issued under endorsement No. CEO/ Bpr/ Gazz-Estt/ 024/ 1825-31, dated: 18-07-2024.


