Whereas, the Notification for inviting applications through online mode on prescribed format, from the post graduate candidates who are the domicile of union territory of Jammu & Kashmir having secured minimum 50% marks in the post graduation in their respective disciplines for their hiring on temporary basis as "Cluster Resource Coordinators for teaching Support" for the academic session 2024-25 (Revised) in various Government High & Higher Secondary Schools for Kashmir Division, was issued vide Directorate of school Education, Kashmir vide above refereed No. and;

Whereas, a list of candidates who had applied online was forwarded to this office by the DSEK through E-Office.

Whereas, on the basis of the said list, the merit was drawn strictly as per the criteria laid down in the advertisement Notification No. 01 DSEK of 2025 dated 09-07-2025 after evaluation of the documents submitted by the candidates at the time of filing of application, by the designated committee constituted by this office Vide No. CEO/Bpr/Estt-G/025/3430-38 dated 25-07-2025, and the meritorious candidates were shortlisted for hiring their services as **Cluster Resource Coordinator for teaching support;**

Now, therefore, in pursuance of the above and after due consideration, the candidates in various disciplines forming **Annexure-A** to this order are hereby hired purely on temporary basis as Cluster Resource Coordinators for the academic session 2024-25 (Revised) in the institutions shown against each, **subject to the following terms and conditions.**

1. The Cluster Resource Coordinator shall be hired on a monthly remuneration of Rs. 25000/= (Rupees Twenty five thousand only) to be released after obtaining fresh satisfactory Character & Antecedents Certificate from the office of Director General, CID J&K and feedback regarding satisfactory performance, punctuality, and attendance certified by the Head of the Institution concerned.
2. The hiring of the candidates as "Cluster Resource Coordinators for teaching Support is purely temporary and need based arrangement, co-terminus with the end of the academic session 2024-25 (revised), or until regular arrangement is made by the Government, whichever is earlier.
3. The temporary hiring of candidates as Cluster Resource Coordinators for teaching Support shall not, under any circumstances, confer upon them any right, claim, or legitimate expectation for continuation beyond the prescribed

- term, nor for regularisation or permanent absorption in any manner whatsoever.
4. The services of the engaged candidate shall be de-hired immediately without notice in the event regular arrangement made by the Government or any other administrative exigency.
 5. The Department reserves the right to de-hire the services of any candidate at any time without any prior notice.
 6. In case any CRC intends to quit the assignment before the expiry of the term, he/she shall be required to serve a written notice of at least two months to the DDO, failing which two months remuneration shall be recovered from him/her.
 7. The hired candidates shall neither be working in any Government/ Semi-Government Department on temporary/ permanent basis nor enrolled in any educational institute (Online/ Offline) for perusing any higher academic/ professional course/ degree.
 8. The candidate shall join in the concerned Institute (where his/her services are ordered to be utilized) within the period of five days from the date of issuance of this order, failing which the candidates will not be allowed to join and no further notice shall be issued to the concerned.
 9. Verification of the following documents in terms of their authenticity and genuineness:
 - a) Domicile Certificate issued by the competent authority.
 - b) D.O.B Certificate (Matriculation).
 - c) PG Degree/Marks Certificate.
 - d) M. Phil in the relevant subject, if applicable.
 - e) Ph.D Degree Certificate, if applicable.
 10. ***The candidate shall furnish an affidavit duly attested by the Judicial Magistrate 1st class, affirming therein that He/she agrees to abide by the terms and conditions laid down in this order in letter and spirit, specially mentioning that they will not claim continuation beyond the stipulated term and shall accept disengagement at any time as per the conditions laid down in the order, without raising any legal dispute.***
