**WHEREAS,** applications were invited from eligible candidates for hiring of **Cluster Resource Coordinators for teaching support in Government High and Higher Secondary Schools of Kashmir Division** for the Academic Session 2023-24 (31<sup>st</sup> March 2024), vide Notification No. 01-DSEK of 2023 Dated: 09-08-2023; and
