WHEREAS; in pursuance to above referred orders and in continuation to this office Order No. 55-CEO of 2021 Dated. 18.10.2021 the seniority list of Teacher Grade-II of District Bandipore was duly published on the official website of the Chief Education Officer, Bandipore (www.ceobpr.co.in) vide No.: CEO/Bpr/Estt-Trs/025/8650-55 dated 19-12-2025 for inviting objections/discrepancies, if any, from the concerned within the stipulated time period;

WHEREAS; the objections received through DDOs/ZEOs were examined after expiry of the notified period and were disposed of on merits strictly in accordance with rules/orders in vogue;

WHEREAS, after completion of all codal formalities and in compliance with the relevant rules, orders, and directions issued by the competent authorities from time to time, the seniority position of Teacher Grade-II was framed;

WHEREAS; on the basis of the seniority, a list of **63 (Sixty Three)** Teacher Grade-II has been prepared, indicating their respective institutions/places of posting for the purpose of drawl of salary only, without conferring any right with regard to transfer, promotion, or seniority beyond what is already determined;

Now, therefore Sanction is hereby accorded to the utilization of allocated vacancies of Teachers (district cadre) from direct quota posts for drawl of salary only in respect of 63 (Sixty Three) Teacher Grade-II in a phased manner after completion of the due process as per the list enclosed as **Annexure-A**, strictly for drawl of salary purposes only, subject to the following conditions:

1. This order is issued purely for salary drawl and shall not be treated as an order of fresh posting, transfer, or adjustment.
2. The drawl of salary shall be regulated strictly in accordance with the relevant rules, orders, and financial provisions in force.
3. The order shall be subject to any clarification/modification issued by the Higher Authorities or outcome of any court case, if applicable.
4. In case any discrepancy is noticed at any stage, the undersigned reserves the right to withdraw or modify this order or its any part, without prior notice.

Accordingly, the concerned Drawing and Disbursing Officers (DDOs) are directed to draw the salary in favour of the said Teacher Grade-II as per rules.


